

WHO PROCESSES YOUR PERSONAL DATA

Koelner Deutschland GmbH with its registered seat in Schondorf, Germany is the controller of your personal data.

Rawlplug Spółka Akcyjna and **Koelner Rawlplug IP Spółka z ograniczoną odpowiedzialnością** with their registered seats in Wrocław, Poland may be the joint-controllers of your personal data (in the meaning of article 26 of GDPR) in relation to data processed in IT systems of Rawlplug Group¹.

WHAT IS THE PURPOSE AND LEGAL BASIS OF PROCESSING

Your personal data collected through our websites or otherwise, if you give us your consent to process your personal data for marketing purposes, are processed for purpose and on legal grounds as follows:

- 1) **indirect and direct marketing of products and services of Rawlplug Group**², for the indefinite time from the date of consent, but not longer than to the date of withdrawal of the consent – on the basis of article 6 pt. 1.a GDPR (hereafter referred to as “consent”)

We collect and process personal data for other purpose than above only with your expressed consent and only within the scope of such consent. You are entitled to withdraw the consent at any time, however the withdrawal of the consent will not affect the lawfulness of processing based on consent before its withdrawal.

Means and ways of communicating with you in regards of our marketing activities are dependent on the essence and scope of you given consent. We plan to conduct communication of a newsletter and promotional (commercial) materials in regards of Rawlplug’s Group products and services.

WHAT PERSONAL DATA WE PROCESS?

We process your personal data you provide to us by contact form on our website or in any other way, in situation you expressly consented to process your personal data indicated by you for marketing purposes. These data may specifically be: name and surname, email address and telephone number

Provision of personal data **is voluntary**.

SHARING OF THE INFORMATION RAWLPLUG RECEIVES

We share your personal information with:

- 1) **processors processing data on our behalf** with regards to activities rendered on our behalf:
 - a) suppliers of marketing services for us;
 - b) administrators of our IT systems and providing us with IT tools and resources;
 - c) advisors, consultants, auditors, legal and tax advisors, accountants etc.
- 2) **other controllers** processing data in their own name:
 - a) couriers and post offices;
 - b) joint-controllers of the personal data from the Rawlplug Group.

THE PERIOD OF PROCESSING

Particular periods of processing of your personal data by us are indicated in the description of purposes and legal basis of our processing above.

TRANSFER OF PERSONAL DATA OUTSIDE EUROPEAN ECONOMIC AREA (EEA)

We currently do not intend to transfer your personal data outside of the European Economic Area.

AUTHOMATED INDIVIDUAL DECISION MAKING

We do not issue any decision basing on automated data processing which produces a legal effect concerning you or considerably affects you.

YOUR RIGHTS

GDPR gives you following rights in relation to your personal data:

- 1) **accessing your personal data** (including receiving copies of them) – under article 15 GDPR;
- 2) **correcting your personal data** – under article 16 GDPR;
- 3) **deleting your personal data** – under article 17 GDPR;
- 4) **to demand restriction of processing** – under article 18 GDPR;
- 5) **to demand transmission of personal data** – under article 20 GDPR.

We may require additional information enabling us to verify your identity and your right to enforce the above rights.

RIGHT TO OBJECT

Apart from rights referred to in preceding paragraphs, you have the right to object, at any time, to processing of your personal data by us (including profiling) for direct marketing purpose. After filing the objection, we will restrain from processing your data for this purpose.

You have also right to object, on grounds relating to your particular situation, at any time to processing of your personal data which is based on legitimate interest or public interest (including profiling). The controller shall no longer process the personal data unless the controller demonstrates compelling legitimate grounds for the processing which override the interests, rights and freedoms of the data subject or for the establishment, exercise or defence of legal claims.

COMPLAINT
