WHAT IS THE PURPOSE AND LEGAL BASIS OF PROCESSING

Means and ways of communicating with you in regards of our marketing activities are dependent on the essence and scope of you given consent. We plan to conduct communication of a newsletter and promotional (commercial) materials in regards of Rawlplug's Group products and services.

WHAT PERSONAL DATA WE PROCESS?

We process your personal data you provide to us by contact form on our website or in any other way, in situation you expressly consented to process your personal data indicated by you for marketing purposes. These data may specifically be: name and surname, email address and telephone number

Provision of personal data is voluntary.

SHARING OF THE INFORMATION RAWLPLUG RECEIVES

We share your personal information with:

- 1) processors processing data on our behalf with regards to activities rendered on our behalf:
 - a) suppliers of marketing services for us;
 - b) administrators of our IT systems and providing us with IT tools and resources;
 - c) advisors, consultants, auditors, legal and tax advisors, accountants etc.
- 2) **other controllers** processing data in their own name:
 - a) couriers and post offices;

RIGHT TO OBJECT

You have also right to object, on grounds relating to your particular situation, at any time to processing of your personal data which is based on legitimate interest or public interest (including profiling). The controller shall no longer process the personal data unless the controller demonstrates compelling legitimate grounds for the processing which override the interests, rights and freedoms of the data subject or for the establishment, exercise or defence of legal claims.

COMPLAINT
