#### WHAT IS THE PURPOSE AND LEGAL BASIS OF PROCESSING

Your personal data collected through our websites or otherwise, if you give us your consent to process your personal data for marketing purposes, are processed for purpose and on legal grounds as follows:

Means and ways of communicating with you in regards of our marketing activities are dependent on the essence and scope of you given consent. We plan to conduct communication of a newsletter and promotional (commercial) materials in regards of Rawlplug's Group products and services.

### SHARING OF THE INFORMATION RAWLPLUG RECEIVES

We share your personal information with:

- 1) **processors processing data on our behalf** with regards to activities rendered on our behalf:
  - a) suppliers of marketing services for us;
  - b) administrators of our IT systems and providing us with IT tools and resources;
  - c) advisors, consultants, auditors, legal and tax advisors, accountants etc.
- 2) **other controllers** processing data in their own name:
  - a) couriers and post offices;
  - b) joint-controllers of the personal data from the Rawlplug Group.

GDPR gives you following rights in relation to your personal data:

- 4) to demand restriction of processing under article 18 GDPR;
- 5) to demand transmission of personal data under article 20 GDPR.

### **COMPLAINT**
